



Reasons of studying at University of Sunderland Hong Kong campus

Hong Kong is a vibrant international city where Eastern meets Western cultures with diversity in lifestyle. It represents a hub of China and rest of the world, but English is used as teaching medium in University education.

Overseas study is no longer just the privilege of exchange students or students studying abroad. The University of Sunderland in Hong Kong is offering 3-year bachelor's (honours) degrees with the option to study in our UK campuses for 1 or 2 years, so that students can broaden their horizons and gain valuable exposure to British culture.



Visa Application

Once you have been accepted by the University of Sunderland, you must get a student visa or entry permit*. All non-local students need one, whether they come for an exchange programme or full-time studies. In general, non-local students should nominate a local sponsor, which can either be the educational institution granting the acceptance or an individual and provide the necessary supporting documents.

Normally, the Immigration Department requires the following documents, while further supporting documents and information in connection with the application may still be required when necessary. It will normally take six weeks to process a visa or entry permit application for study upon receipt of all the required documents - apply as far in advance as possible!

Documents to be submitted by the applicant:

Photocopy of your valid travel document

**A letter of acceptance from
the education institution**

Photocopy of proof of your financial support
e.g., bank statements, savings account passbooks,

(if the sponsor is the education institution)

Internship



Non-local students of full-time locally-accredited local or non-local programmes at the undergraduate level or above whose study period is not less than one academic year may take up an internship subject to the following conditions:

- The internships must be study/curriculum-related and be arranged/endorsed by the institutions they are studying in.
- The duration of the internship is up to one academic year, or one-third of the normal duration of the relevant full-time academic programme, whichever is shorter.

There is no restriction on the nature of work, level of salary, location, number of working hours and employers for the internship arrangements.

However, part-time job is not allowed for international students.
